### PLEASE READ CAREFULLY IF YOU ARE CONSIDERING NEW ZEALAND HOMESTAY ACCOMMODATION

The school has established the following regulations regarding the use of mobile phones and electronic devices. We ask all parents and students to carefully read and strictly adhere to the policy.

- 1. Centralised Management of Electronic Devices
  - 1. Upon arrival, all mobile phones and personal electronic devices (including but not limited to mobile phones, iPads, gaming devices, etc.) will be collected and securely kept by the school's international department or accompanying teachers.
  - Except during designated times, students are not allowed to possess or use any electronic devices privately. Hiding, borrowing, or sharing devices is strictly prohibited.
  - 3. If a student is found concealing or using electronic devices in violation of this policy, the school will impose serious consequences depending on the situation, and the student and parents will bear full responsibility.

### 2. Scheduled Communication with Parents

- Students are only allowed to contact their parents at scheduled times at the school. During this time a school phone will be available for limited use (we suggest a maximum of 10 minutes per session).
- 2. Students are not allowed to contact parents outside of these scheduled days and times unless there is an emergency.
- In case of an emergency, students can communicate through the school and international staff will notify the parents immediately if necessary.

- To help students avoid excessive reliance on parental comfort in the early stages of adaptation, allowing them to focus on problem-solving and building resilience.
- To prevent misunderstandings or unnecessary concern caused by emotional or exaggerated feedback, which could interfere with the smooth operation of the program.
- To encourage students to fully immerse themselves in New Zealand's local school and homestay culture, enhancing their English communication skills and intercultural understanding.

### 4. A Growth Journey for Both Students and Parents

We understand that letting your child live independently in a foreign country for the first time can be challenging. But please trust:

- Your child is capable of overcoming difficulties and growing through this experience, with full support from our teachers and homestay families;
- The school and program organisers have established comprehensive safety and support systems, ensuring your child is 100% safe both at school and in their homestay.

This is not only a valuable journey of growth for the child but also an opportunity for parents to practice trust and letting go.

### **Definitions**

  - c) Act means the Education and Training Act 2020.
  - d) Agreement means this Agreement including any schedules.
  - e) Application Form means the standard enrolment form which forms the cover page of this Agreement.
  - f) Code means the Education (Pastoral Care of Tertiary and International Learners) Code of Practice 2021.

  - i) Fee means fees payable by the Parents to the School as per the Fee Schedule.

The School may terminate this Agreement if there is a Welfare Issue and the School forms the view that it cannot reasonably continue to meet its obligations under the Code or the Act with respect to the health and wellbeing of the Student within the School.

29) Where appropriate the School will follow the process set

out in the Investigation Policy which is annexed to this Agreement as Schedule Three when exercising the power in clause 28 of this Agreement, but nothing in this Agreement shall limit the power of the School to take urgent action, including terminating this Agreement or sending the Student home, where it considers that it is necessary to do so.

### **General Matters**

- 30) No party to this Agreement is liable to the other for failing to meet its obligations under this Agreement to the extent that the failure was caused by an act of God or other circumstances beyond its reasonable control.
- 31) This Agreement shall be construed and take effect in accordance with the non-exclusive laws of New Zealand. In relation to any legal action or proceedings arising out of or in connection with this Agreement the
  - Parents irrevocably:
    a) Submit to the non-exclusive jurisdiction of the Courts of New Zealand; and
  - Agree that proceedings may be brought before any Court including any forum constituted under the Arbitration Act 1996 within New Zealand, and waive any objection to proceedings in any such Court or forum on the grounds of venue or on the grounds that the proceedings have been brought in an inconvenient forum.
- 32) Notices given under this Agreement must be in writing and given to the addresses set out in the Application Form. Those notices sent by post will be deemed to

have been received ten (10) days after posting.

33) Notices may also be given by sending an email to the email addresses specified on the first page of this agreement and will be deemed to have been received 12 hours after it has been sent.

- 34) This Agreement contains the entire understanding of the rnis Agreement contains the entire understanding of the parties and overrides any prior promises, representations, understandings or agreements. The terms of the Agreement may be changed by the School in consultation with the Student, and Parents, except where such change is required by New Zealand legislation or the Code. This Agreement shall continue in force during the Period of Enrolment with the School.
- The School shall at all times comply with the Health and Safety at Work Act 2015.
- 36) Nothing in this Agreement limits any rights that the Parents or Student may have under the Consumer Guarantees Act 1993.
- 37) The parties acknowledge that prior to signing this Agreement, they have had the opportunity to seek independent legal advice in respect of its content and effect.
- 38) This Agreement may be executed in one or more counterparts, each of which when so executed and all of which together shall constitute one and the same Agreement. Delivery of executed counterparts may be delivered by email, facsimile transmission or through an internet service set up for that purpose.

# **Investigation Policy**

 The following is the School's current policy for dealing with Disciplinary Actions and Welfare Issues. This is not intended to restrict the School's general powers relating to discipline and this policy may be changed from time to time at the discretion of the School.

#### Overview

- Except in serious situations where immediate termination of the Agreement is necessary, or where the breach does not warrant any formal response other than a warning, the School will endeavour, where appropriate, to follow a two stage investigation process.
- 3. In Stage One, the School will investigate and determine the facts of the situation being considered (the Situation), and will reach a conclusion on what happened and whether there is a Welfare Issue or an incident that requires Disciplinary Action or the termination of the Agreement.
- 4. In Stage Two, if the School has determined some response is required, the School will consider the appropriate outcome for the situation, up to and including termination of the Agreement.
- During this process, the Student will have an opportunity to provide a response to the Situation and any proposed outcome that the School is considering taking (the Proposed Action).
- 6. This policy does not limit the School's power to take appropriate action urgently and without following this process if this is necessary having regard to the seriousness of the Situation
- 7. This policy also does not limit the School's power to suspend the student for the duration of the investigation process where suspension is considered necessary for the safety or education of any person.
- 8. When the School is conducting an investigation

involving the Student it will endeavour to provide the Student with the following:

- (a) a written summary of the Situation (as it understands it) or the Proposed Action;
- (b) an opportunity to respond to the Situation or the Proposed Action, either in person or in writing or both, at the choice of the Student;
- (c) an opportunity to consider the Situation or the Proposed Action for a reasonable period of time (having regard to the seriousness of the Situation or the Proposed Action) before giving a response;
- (d) an opportunity to contact his or her Parent before giving a response, unless the delay caused by contacting that person is unreasonable having regard to the seriousness of the Allegation or Proposed Action;
- (d) an opportunity to have an independent support person of his or her choice present at any meeting relating to the investigation process;
- (e) an opportunity to meet with that support person in private at any stage during the investigation process;
- (f) an opportunity to have a translator present (or otherwise facilitate the student participating in the process in his or her own language) during any meeting or process if the School or the Student considers that a language barrier means that a translator is required; and
- (g) a copy of this policy setting out the rights which the Student has when engaging in the investigation process.

### Stage One: Incident Investigation

- 9. When the School learns of any incident or any other thing that may be a breach of the Agreement or might otherwise warrant a disciplinary response or which may constitute a Welfare Issue, the School will notify the Student of the Situation and will provide the Student with an opportunity to give a response.
- 10. Where appropriate, having regard to the seriousness of the Situation, the Student will have the opportunity to respond transfereither in person or in writing or both, at the choice of the Student. The School will receive this response and give it genuine consideration before making a decision about the Situation.
- 11. When the School makes a decision about the Situation it will advise the Student and parent, in writing if possible, about its conclusion as to what happened and whether it considers that it requires some kind of formal response whether Disciplinary Action, Termination or other intervention.

# **Stage Two: Outcome Discussion**

The School shall only give such Consent where approved by the Parents in terms of the Contract of Enrolment.
- 8. The School may take such measures as it considers appropriate (acting reasonably) to monitor compliance with the Code. This may include, without limitation, regular check-ins with both the Student and the Residential Caregiver.
- 9. Unless otherwise agreed in writing, the Student will be entitled to commence their Homestay at the Accommodation 5 days prior to the Period of Enrolment (as that term is defined in the Contract of Enrolment) commencing and 5 days following the end date of the Period of Enrolment (as that term is defined in the Contract of Enrolment). Should this Agreement be terminated prior to the expiry of the Period of Enrolment, the Student will be required to vacate the Accommodation immediately. The School may, at its sole discretion, and without any obligation on it to do so, extend the time for the Student to vacate the Accommodation. Any such extension shall be given in writing and shall be without prejudice to the School's right to later insist that the Student immediately vacate the Accommodation.

# **Expectations**

- The Student will comply at all times with the Accommodation Requirements and the Parents shall work with the School to ensure such compliance.
